3. Pass the Reading, Math, and Ability-to-Assist test provided by the district with a score of 80% or better on all three exams. Qualified applicants will be contacted for the exam date. No walk-ins will be allowed.
4. Two (2) years of work experience with junior high school-aged students
5. Valid CA driver's license, valid automobile insurance and clean DMV record
6. First Aid and CPR Certificate issued by an authorized agency, desired
